TOWN OF INUVIK BY-LAW 94-1359



BEING A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO AUTHORIZE THE MAYOR AND SENIOR ADMINISTRATIVE OFFICER TO EXECUTE, ON BEHALF OF THE TOWN, AN ENCROACHMENT AGREEMENT REGARDING LOT 47, BLOCK 20, PLAN 2319.

WHEREAS pursuant to Section 130 of the Cities, Towns and Villages Act, R.S.N.W.T., 1988 c. C-8 a Municipal Corporation has the power to contract for municipal purposes:

**AND WHEREAS** the Council of the Municipal Corporation of the Town of Inuvik wishes to enter into a written agreement for the purpose of dealing with specific encroachments;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipal Corporation of the Town of Inuvik in the Northwest Territories, at a duly constituted session enacts as follows:

- 1. In this By-Law:
  - (a) "Agreement" means the form of agreement attached hereto between the Town and MGS Investments Ltd. and Talil Khatib and Gasga-Olton Ltd.;
  - (b) "Town" means the Municipal Corporation of the Town of Inuvik;
  - (c) "Mayor" means the Mayor of the Town;
  - (d) "Senior Administrative Officer" means the Senior Administrative Officer of the Town appointed pursuant to Section 43 of the Cities, Towns and Villages Act, R.S.N.W.T., 1988 c. C-8, or his/her delegate.
- 2. The Mayor and Senior Administrative Officer are hereby authorized to execute, on behalf of the Town, the written agreement with MGS Investments Ltd. and Talil Khatib and Gasga-Olton Ltd. in the form appendant hereto as Schedule "A", by affixing the Corporate Seal of the said Town thereto and signifying their presence by inscribing their names in the spaces provided for the purpose in the said form of Agreement.
- 3. This By-Law shall come into effect upon receiving third reading and otherwise meets the requirements of Section 57 of the Cities, Towns and Villages Act.
